#### **Utility Service Fees & Penalties**

Past Due Charges and Fees: late payment fee will be the greater of \$5.00 or 1.50% for each infraction per billing cycle. Late payment interest 1.50 % per billing cycle on the total delinquent amount.

#### § 54.12 TURN ON/TURN OFF VIOLATION.

Town officials are the only ones permitted to touch the water meter for any reason. If ordinance is not followed violators will be fined up to \$750.00 dollars.

#### § 150.001 AUTHORITY TO ENTER.

Town officials under the ordinance listed above are permitted to enter any property when there is reasonable cause to believe there is an ordinance violation.

#### § 53.12 TURN ON/TURN OFF FEES

Owner of the property is responsible for keeping their meter clear. Whether it is winter or summer if you choose to have any service done pertaining to the meter it must be cleared off prior to town employees coming.

#### § 72.04 PROPERTY IN ROAD RIGHT-OF-WAY.

Property owners shall keep all property out of Town right of way including but not limited to trash cans, cars, and landscaping. If owners' property is in the right of way Town officials have the right to move it at the owner's expense. If owners choose to leave property in the Town's right of way and it damages the Town's equipment owners will be responsible to repair, Town property.

#### § 72.03 SNOW REMOVAL NEAR RESIDENCES.

Owners of property are responsible for clearing snow berms left by plows. Residents are prohibited from placing snow removed from their driveways onto or across Town road or into the road right of way.

Please note as the owner of the property it is your responsibility to know and understand town Ordinance and follow them accordingly.
